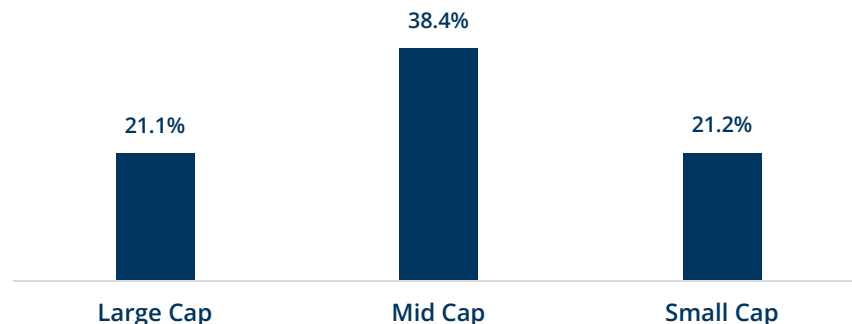

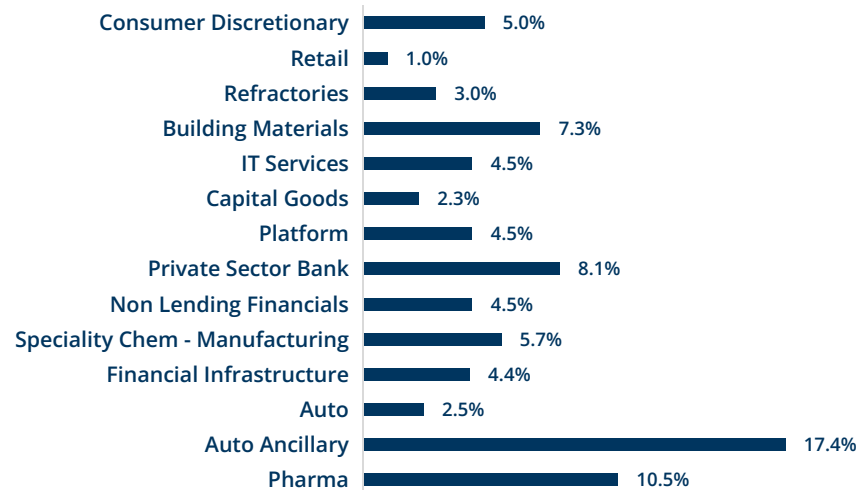

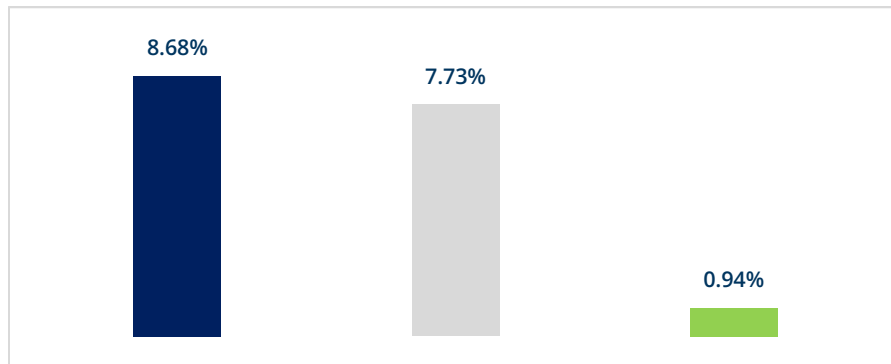

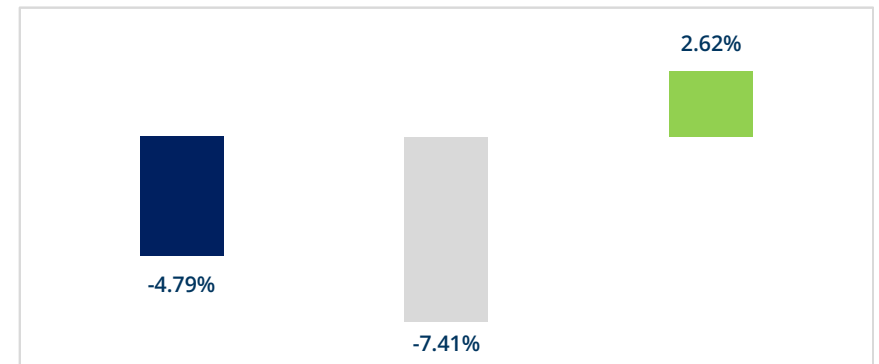


Outperformed 10 out of 20 up quarters
